

# Uni-track Program

## Frequently Asked Questions for Students

### How do I enroll for Uni-track credit?

Your teacher will provide enrollment information for your specific class when it begins. You will enroll online using [MyFresnoState](#), the same enrollment system that Fresno State students use to enroll in their classes each semester.

### How do I pay for Uni-track?

Payment instructions may be found in the Registration Guide on the Uni-track website. Each Uni-track class costs \$40. Payment is due by the enrollment/payment deadline for the class.

### Can my teacher or parent/guardian enroll me in Uni-track?

We ask that students enroll themselves and communicate directly with Fresno State about their enrollment.

### May I drop a Uni-track class after enrolling?

Yes, you may drop your Uni-track class without penalty by the deadline specified in the Registration Guide on the Uni-track website. Depending on your drop date, your class may appear on your transcript with a "W" grade, meaning you were enrolled in the class, but withdrew without penalty.

### Will I be automatically removed from Uni-track if I withdraw from my high school course or drop out?

No! If you withdraw from your high school class, you will not be withdrawn from Uni-track automatically. You must do that separately through MyFresnoState by the deadline in the Registration Guide.

### May I prevent my high school grade from being entered into my Fresno State transcript?

You may drop out of the Uni-track program if you do not wish to have your grade on your Fresno State transcript. See the Registration Guide for dates and deadlines. Depending on your drop date, your class may appear on your transcript with a "W" grade, meaning you were enrolled in the class, but withdrew without penalty. If the drop deadline has passed, your grade will be posted on your Fresno State transcript and subject to University grading policies.

### May I withdraw retroactively from Uni-track if I missed the drop deadline?

Retroactive withdrawals from Uni-track (i.e. withdrawals after the drop deadline) will only be approved if you provide a serious and compelling reason for missing the drop deadline (e.g. a serious medical issue or death in the family prevented you from dropping on time). Please contact the program for assistance.

### Are refunds available for the Uni-track program?

No, refunds are not available if you drop out of the Uni-track program after paying the class fee.

### How do I find out if my school offers any Uni-track courses?

A list of active Uni-track classes may be found on the program website. You may also check with your high school principal, learning director, counselor, and/or academic advisor to find out if your high school is planning any future Uni-track offerings.

### **May I enroll for Uni-track credit even if my school or teacher does not offer that option?**

No, teachers must apply to participate in the Uni-track program before students may enroll. Teachers, please visit the Uni-track website for more information on the application process.

### **What is the benefit of enrolling in Uni-track for my AP class?**

If you are planning to attend Fresno State after graduation, enrolling in Uni-track may be a more cost-effective alternative to the AP test as you generally receive similar credit. If you are unsure, take these steps:

1. Find your class on the [Uni-track website](#) and note the articulated Fresno State course.
2. Find your AP test on Fresno State's [External Exam Credit](#) list and note the articulated Fresno State course.
3. If the courses match, you may enroll in Uni-track instead of taking the AP test, and your grade in your high school class will be entered into your Fresno State transcript.

### **May I receive credit for a Uni-track class if I take an AP test for the same class?**

If you attend Fresno State after graduating high school, the University will not count Uni-track and AP test credit for the same class. Other universities may have different restrictions.

### **Are there any restrictions on using Uni-track credit toward a Fresno State degree?**

Uni-track credit may not be used toward residency requirements for a baccalaureate (i.e. bachelor) degree at Fresno State. Since Uni-track classes are all lower-division, the residency limitation should have limited impact on students who subsequently enroll at Fresno State.

"Residency" requires a student to earn a minimum number of units by taking classes at the university that grants their degree. Students who wish to earn baccalaureate degrees at Fresno State must take at least 30 units in residency at the University. Of those 30 units, 24 must be in upper-division courses, 12 must be in the student's major, and 9 must be in courses that meet General Education requirements.

### **Will my Uni-track credit apply to any degree program at any university?**

Uni-track courses are generally recognized for college credit, but may apply differently to pre-professional degrees (e.g. as pre-medicine). Also, some universities will not accept Uni-track course credit toward degrees. In particular, some University of California campuses limit or prohibit Uni-track credit.

We highly encourage you to check with universities you may attend for program-specific information and approval regarding Uni-track credit.
